## SPECIAL RULES

1. This competition is held under the direct supervision of the Southwestern Exposition and Livestock Show and is sanctioned by the Texas Palomino Exhibitors Association and the Palomino Horse Breeders of America. This will be a Triple Point Show and will be judged concurrently by three (3) judges.
2. This is a **Stock Horse Type Show**.
3. **Eligibility.** All horses must be registered with the Palomino Horse Breeders of America. All horses will be shown and judged in accordance with the rules of the Palomino Horse Breeders of America. Palomino Bred horses must have one Palomino parent and be registered in the Palomino Horse Breeders of America. A PHOTOCOPY OF EACH HORSE'S REGISTRATION PAPERS (FRONT AND BACK) MUST ACCOMPANY EACH ENTRY. **Note: Entries submitted without these papers will not be accepted and will be returned to the exhibitor. To be eligible to compete in the performance halter class, a Register of Merit in performance must be earned and recorded on the horse's show record. The Register of Merit applies to the horse. If the horse is transferred, the horse is eligible to compete with the new owner. This applies to all divisions of the Palomino Horse Show. Entry applications must be filled out completely.** Horses must be entered and shown under the name of the owner as recorded with the Palomino Horse Breeders of America at the time of entry. For change of ownership, see Horse Show General Rules and Regulations 9, [Page 25](#).
4. **Membership.** Exhibitors in the Palomino Horse Show must present the following current membership items at the Horse Show Office before receiving their packet and exhibitor number.

**OPEN CLASSES** -----Exhibitor membership number, must have current year. Owner membership number, must have current year.

**AMATEUR CLASSES** -----Exhibitor membership number, must have current year. Owner membership number, must have current year.

**YOUTH CLASSES** -----Exhibitor membership number, must have current year. Owner membership number, must have current year.

5. **Show Fee.** A \$65 show fee is required for each horse entered. Late entries must pay a show fee of \$100. **No entries accepted after December 30. Entries must be submitted on entry applications obtained from the Southwestern Exposition and Livestock Show, from our website [fwssr.com](http://fwssr.com) or submitted online by [clicking here](#) or at [fwssr.com](http://fwssr.com).**

DECEMBER 30 AND SUBMITTED WITH APPROPRIATE LATE FEE.

1. Payment (cash, check or money order) for entry fees and additional passes must be submitted with entries. **Any entries received without payment will be returned.** Credit cards **WILL NOT** be accepted for entry related fees submitted in person or by mail.
  2. Please type or print legibly all information required on Entry Applications and Responsible Party/Agent Summary Sheets.
  3. All entries must include appropriate signatures.
  4. Copy of horse registration papers and exhibitor/owner membership card must accompany entry.

**ALL ENTRIES MUST BE SUBMITTED WITH A RESPONSIBLE PARTY/AGENT SUMMARY SHEET. ONE RESPONSIBLE PARTY/AGENT SUMMARY SHEET IS REQUIRED FOR EACH GROUP OF ENTRIES.**

**RESPONSIBLE PARTY/AGENT:** All correspondence – including confirmation of entries, passes and premiums will be mailed to the responsible party/agent. Premium checks will be made payable to the owner – mailed to responsible party/agent's address. (Owner can serve as Responsible Party/Agent). Following the completion of the Show, responsible party/agents will be contacted to obtain a Form W-9 for each owner in which the owner's premium check is \$600 or more. The premium check will not be released until a valid, signed Form W-9 is returned to Southwestern Exposition and Livestock Show.

**OWNER:** Owner of the animal will be as it appears on the registration papers or lease agreement at the time the entry application is submitted.

**CONFIRMATION OF ENTRIES:** Once an entry is received and processed, the responsible party/agent will receive a confirmation of the entry along with the appropriate passes. Please open immediately. If the confirmation of entries does not agree with your understanding of the entries, please notify our office immediately. **Class changes or additions will not be permitted after NOON the day preceding the class involved. Class changes or additions accepted by mail or in person in the Stock Show Main Office located in the Amon G. Carter Jr. Exhibits Hall building or submitted online at fwssr.com.**

**TACK STALLS:** Tack stalls should be ordered on Horse Show Responsible Party/Agent Summary Sheet and paid for with entries. If sharing tack stalls, **DO NOT** pay for tack stall with two separate checks.

**STALL REQUESTS:** Any requests to be stalled with someone who is not acting as your responsible party/agent should be indicated on your responsible party/agent summary sheet with the exact name of the owner/responsible party/agent you wish to be stalled with. The most effective way to insure that a group will be stalled together is for someone to act as one responsible party/agent. Otherwise every effort will be made to accommodate stalling requests but there is no guarantee.

**MEMBERSHIP CARDS:** Current individual membership cards must accompany entry and be shown at stall office before entry numbers will be issued. Please refer to each breed in the Premium List for membership card requirements.

**TRAILERS: NO RV HOOKUPS OR OVER NIGHT PARKING WILL BE AVAILABLE FOR HORSE SHOW EXHIBITORS.** No Overnight Camping on the Stock Show grounds. Any trailer, vehicle or vehicle/trailer combinations left overnight will be towed at owner's expense. Parking space will be provided for all trailers. Exhibitors with vehicles pulling trailers will be directed to an appropriate parking location by Stock Show staff and will remain on Stock Show grounds at staff's discretion. However, no trailer, vehicle or vehicle/trailer combination will be allowed to remain on Stock Show grounds overnight. Trailers cannot be unhooked from vehicles and left on Stock Show grounds (must be moved to appropriate trailer parking location as directed by Stock Show staff).
