Owner/Exhibitor/Agent must check in with Show Secretary to present registration papers, membership cards, negative coggins test, and arrange payment with cash, signed check or credit card.

Please read carefully & sign:

In order to be eligible for year-end awards you must:

1. Sponsor a class for each horse
2. Work 2 segments per horse.
3. Show at 3 of the 4 shows in 2020. (All-Breed show at 2 shows)
4. All-Around year end awards – per division
 - A. Must qualify each day for the points to count
 - B. Must show in halter/color or showmanship (minimum 10 points) & 2 performance events- (minimum 10 points).
 - C. Awards may be combined in Youth, Amateur, Open & All-Breed if special awards are not sponsored.
5. Individual class year end awards
 - A. Must show to 7 judges (3 judges for All-Breed)
 - B. Earn at least 10 club points in that class.
6. Awards will be held if there is any outstanding money owed to TPEA.
7. Add/Scratch sheets must be filled out or you will be charged for the class. (texting someone in the office does not count – you must also fill out a scratch form and turn it in).
8. Pre-entries are due the Monday before the show. Postmark & email dates will be strictly adhered to. Payment is due at the show. If you are unable to attend at all, please let Miss Billie know. The office needs a copy of the Coggins, registration papers & all membership cards (owner & exhibitor).
 - A. PHBA Membership cards should have TPEA listed as affiliate, if not, you must pay for an associate membership in order to show (family memberships are available)
9. The Holiday Inn has a special rate for TPEA members, but the rooms will be released 3 weeks before the show.
10. The exhibitor number goes with the horse, it must be used at every TPEA show. You cannot change back numbers or you will loose club points.
